V-Nee Yeh is the beneficial holder of more than 20.0% of the issued share capital of Argyle Street Management Holdings Limited ("ASMHL"). ASMHL is the beneficial holder of more than 50.0% of Argyle Street Management Limited and ASM Connaught House General Partner Limited ("ASMCHGP"). ASMCHGP, being the general partner of ASM Connaught House Fund LP ("ASMCHF"), manages, controls the operation of and determines the policy with respect to ASMCHF.

As a consequence of the acquisition of units in Saizen REIT by ASMCHF, V-Nee Yeh's deemed interest has increased from 12.945% to 13.034%.
