ASMHL is the beneficial holder of more than 50% of ASM Connaught House General Partner Limited ("ASMCHGP"). ASMCHGP, being the general partner of ASM Connaught House Fund LP ("ASMCHF"), manages, controls the operation of and determines the policy with respect to ASMCHF.

As a consequence of the acquisition of units in Saizen REIT by ASMCHF, Kin Chan's deemed interest has increased.
