ASMHL is the beneficial holder of more than 50.0% of Argyle Street Management Limited and ASM Connaught House General Partner Limited ("ASMCHGP"). ASMCHGP is the general partner of ASM Connaught House Fund LP ("ASMCHF").

As a consequence of the acquisition of units in Saizen REIT by ASMCHF, V-Nee Yeh's deemed interest has increased from 12.966% to 13.003%.
