V-Nee Yeh is the beneficial holder of more than 20.0% of the issued share capital of Argyle Street Management Holdings Limited ("ASMHL"). ASMHL is the beneficial holder of more than 50.0% of Argyle Street Management Limited ("ASML"). ASML is the beneficial holder of more than 20% of the voting shares of ASM Hudson River Fund ("ASMHRF"), ASM Asia Recovery Fund ("ASMARF") and other ASM Funds. ASMARF is the beneficial holder of more than 50% of the issued share capital of ASM Asia Recovery (Master) Fund ("ASMARMF"). ASML is also the discretionary investment manager of ASMHRF and ASMARMF.

As a consequence of the disposal in units of Saizen REIT by ASMHRF and ASMARMF, V-Nee Yeh's deemed interest has decreased from 9.106% to 8.957%.
