Kin Chan is the beneficial holder of more than 20% of the issued share capital of Argyle Street Management Holdings Limited ("ASMHL"). ASMHL is the beneficial holder of more than 50% of Argyle Street Management Limited ("ASML") and ASM Connaught House General Partner Limited ("ASMCHGP"). ASMCHGP, being the general partner of ASM Connaught House Fund LP ("ASMCHF"), manages, controls the operation of and determines the policy with respect to ASMCHF. ASML is the beneficial holder of more than 20% of the voting shares of ASM Co-Investment Term Trust I ("ASMCOTT") and ASM Hudson River Fund ("ASMHRF").

As a consequence of the acquisition of units in Saizen REIT by ASMCHF, ASMCOTT and ASMHRF, Kin Chan's deemed interest has increased.
