Argyle Street Management Holdings Limited ("ASMHL") is the beneficial holder of more than 50% of the voting shares of Argyle Street Management Limited ("ASML"). Argyle Street Management Limited ("ASML") is the beneficial holder of more than 20% of the voting shares of ASM Asia Recovery Fund ("ASMARF") and other ASM funds. ASMARF is the beneficial holder of more than 50% of the issued share capital of ASM Asia Recovery (Master) Fund ("ASMARMF"). ASML is also the discretionary investment manager of ASMARMF.

As a consequence of the disposal of units in Saizen REIT by ASMARMF, ASMHL's deemed interest has decreased from 6.013% to 5.984%.
