V-Nee Yeh is the beneficial holder of more than 20.0% of the issued share capital of Argyle Street Management Holdings Limited ("ASMHL"). ASMHL is the beneficial holder of more than 50.0% of Argyle Street Management Limited ("ASML") and ASM Connaught House General Partner Limited ("ASMCHGP"). ASMCHGP is the general partner of ASM Connaught House Fund LP ("ASMCHF"). ASML is the beneficial holder of more than 20% of the voting shares of ASM Hudson River Fund ("ASMHRF"), ASM Asia Recovery Fund ("ASMARF") and other ASM Funds. ASMARF is the beneficial holder of more than 50% of the issued share capital of ASM Asia Recovery (Master) Fund ("ASMARMF"). ASML is also the fund manager of ASMCHF, ASMHRF and ASMARMF.

As a consequence of the disposal in units of Saizen REIT by ASMCHF, ASMHRF and ASMARMF, V-Nee Yeh's deemed interest has decreased from 8.169% to 7.982%.
